- A. All the PP's who have applied for issuance of TOR by online registration of the proposals can take-up the EIA studies as per the Standard TOR developed by the Minister of Environment, Forest & Climate Change, New Delhi. The SEAC will have the right and the responsibility of stipulating additional TOR in specific Projects considering its project features.
- B. The State Expert Appraisal Committee will consider the project proposals for prior EC, in its meeting to be held on 17/4/2018 at 10.30 A.M. at M.P. Pollution Control Board, E-5, Arera Colony, Bhopal. The Project proponents are requested to attend the meeting in person or depute a competent person having proper & full background of the proposed project with proper authorization in writing (Capacity-Authority Letter), who can explain the project and also respond to the queries & offer his views on suggestions made by the committee. Such person would be required to make a presentation on the salient features of the project, the related environmental issues, risk assessment and proposed Environmental Management Plan. His commitment before the committee will be treated as your commitment.
- C.
