Such person would be required to make a presentation on the salient features of the project, the related environmental issues, risk assessment and proposed Environmental Management Plan. His/Her commitment before the committee will be treated as your commitment. In this context you are advised & requested to mail a soft copy of all necessary documents (with case number) such as Application form 1, PFR, EIA/EMP, Approved Mining Plan and other relevant papers at [seacmining@gmail.com](mailto:seacmining@gmail.com) immediately so that each member could offer his views on the proposal during the presentation.

*"I hereby give an undertaking that the data and information given in the application and enclosures for environmental clearance are true to the best of my knowledge and belief without concealing any fact and I am aware that if any part of data and information submitted is found to be false or misleading at any stage the project will be rejected and clearance given, if any to the project will be revoked at our risk and cost." The PP's who have not submitted above declaration at the time of online submission/with hard copy, should bring above affidavit at the time of presentation.*
