The area having gentle slope. It is about 1.6 km northeast of village Chhaprimiya. The maximum elevation is about 528m from MSL The estimated remaining geological reserve in the area is <b>200000m<sup>3</sup></b> Mineable reserve – <b>81129m<sup>3</sup></b> .
